E- Tenders ([www.wbtenders.gov.in](http://www.wbtenders.gov.in)) in WB Form No 2911(ii) are hereby invited by the undersigned on behalf of the Governor of West Bengal for Construction of Excavation of **Water Harvesting Structures/ DUG WEL**etc. at different places of Md. Bazar& Suri-IBlock in Birbhum District under WDC-PMKSY-2.0 scheme of Project Id No.:- Birbhum (WDC 2)/01/2021-'22 & Birbhum (WDC 2)/02/2021-'22.

Bonafide and Resourceful Contractors/Agencies, Engineers/Labour Co-Op Society etc. having experience of similar nature of earth work including similar nature of construction work and having financial capability to execute same nature of works within preceding three years i.e. **2020-21, 2021-22 & 2022-23** (Acceptance-cum-work order along with payment certificate from competent authority with a minimum credential 40% of the tender amount in a single work order) will be eligible to participate in the above tender (Self attested photo copy of documents like **PAN, I. Tax return of last three years, P. Tax registration and up to date clearance, G.S.T registration certificate and clearance of last quarter, Trade License, Bank details, Details of his machineries, previous experience of work in watershed development activities and Audit & Balance Report for last three years from Chartered Accountant** should be enclosed). Registered Co-operative Societies are required to furnish valid Bye Laws, Current Audit Report, Valid clearance Certificate from A.R.C.S. for the current financial year along with other relevant supporting papers.

Earnest money against the work as shown in the table below shall have to be paid online from Bank gateway mentioned in the portal in favour of the Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum.

The tenderers should quote their rate on percentage basis over the scheduled amount i.e. ABOVE, BELOW or AT PAR both in words & figure on the specified space page of the tender paper including all other costs.

**The intending tenderer/s may visit the site/place/project site and satisfy himself to the extent of working difficulties and problems of the proposed site (if any) for a particular work before submitting the tender in consultation with the Concerned Micro Watershed Committee Association. The selected tenderer will have to form 'Users' Group' and collect the beneficiaries' contribution @ 5/10 % as the case may be before issuance of work order by the concerned Micro Watershed Committee Association / PIA for a work in terms of the guideline of New Generation Watershed Development Projects under WDC-PMKSY 2.0, Clause 26.1.**

No interruption in work will be allowed due to any site condition. Difficulties and inconveniences should be taken into consideration by the bidder. The bidder shall have to arrange at his own cost all sorts of manpower to conduct the works.

The undersigned will have the sole discretion to decide the eligibility of the tenderer on the basis of submitted documents and the right to refuse any application of tenderer found ineligible after scrutiny. Eligible tenderer should show their documents in original as enclosed in the application at the time of obtaining the Tender Papers.

Acceptance of lowest or any other tender is not obligatory on the part of the undersigned. The undersigned reserves the authority to reject any tender or all tenders without assigning any reason what so ever.

The payment will be made as and when fund will be available from the concerned source. No claim/complain, whatsoever for delay in payment, if any, will be entertained. Contractors / Agencies are requested to quote their rates accordingly.

### Terms and conditions

1) Eligibility criteria for participation in the tender:

The bidder will be established & experienced in undertaking **similar types of work** having credential (from Government Officer, **not less than the rank Assistant Director**) in **Departmental & Zilla Parishad Works only @ 40%** of work value in a single job. Capability statement in separate sheet should be submitted along with tender.

2) Earnest Money:

Earnest money against the work as shown in the above table shall have to be paid online through the portal in favour of the Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum. The earnest money of successful tender will be converted as security deposit. Earnest money of unsuccessful tender will be released after the finalization of the lowest tender.

3) Mode of Work:

The selected tenderers shall have to complete the work at the spot under supervision of concerned engineer of this establishment. The date & time of work should be fixed in consultation with the engineer concerned and to be communicated to the undersigned well in advance.

4) Payment Terms:

i) The payment will only be made after satisfactory completion of whole works. The work must be completed in stipulated time period and No Time Extension of work or any RA bill will be entertained due to delay of work by the successful bidder or tenderer without any valid ground/reason. Extension of time or RA bill will be allowed due to delay of work for natural disaster or any acceptable reason which considering by the respective Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum. Problems like manpower and machinery or Agricultural field should not be allowed. Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum is the sole authority to allow necessary permission for time extension.

ii) **In terms of the guideline of New Generation Watershed Development Projects under WDC-PMKSY 2.0, Clause 26.1 selected bidder will be liable to collect the contribution (5% or 10% whichever is applicable) in Cash or in the form of voluntary labour at the time of scheme execution with proper receipt. A sum equivalent to monetary value of voluntary labour will be deducted from the bill and transferred from Watershed project Account to WDF Account.**

iii) **Payment is to be made by the concerned Micro Watershed Committee Association of Project Id No.:- Birbhum (WDC2)/01/2021-'22 & Birbhum (WDC2)/02/2021-'22, Birbhum after satisfactory completion of work.**

5) Security Deposit:

The successful tenderer shall have to deposit the security money either @ 3% of the tendered value or the balance amount over the Earnest money (2%) already deposited in favour of the Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum before preparation of final bill. Formal agreement will be done by the successful tenderer with the tender accepting authority within 7(seven) days from the date of issue of acceptance letter. The formal work order for the supply will be issued after execution of formal agreement by purchasing agreement papers with an amount **Rs. 755.00** by the successful tenderer with the tender accepting authority. Total security deposit will be released after 90 days for Water Harvesting Structure and 180 days for Dug Well.

Agency have to submit Additional Performance Security @10% in addition to scheduled 10% performance security in form of the "**Bank Guarantee**" in terms of G.O. No. 4608-F(Y), dated, 18/07/2018 before issuance of "Work Order" in his favour. The Additional Performance Security will be returned immediately on successful completion of the contract. If he fails to complete the contract successfully within the scheduled period this additional performance security will be forfeited.

Others:

In case of any unscheduled holidays on the aforesaid dates, the next working date will be treated as schedule/prescribe date for the same purpose.

6) Final Measurement:

## Special terms and Conditions

1. **During the scrutiny** on opening of tender, if it is come to the notice to the tender inviting authority /Tender committee that the credential or any other paper of any bidder is incorrect/manufactured/fabricated then the tender will be out rightly **rejected without any prejudice** with forfeiture of earnest money forth with.
2. **Before issuance of the work order**, the tender inviting authority may verify whether the credential & other document of the lowest tenderer is manufactured or false or fabricated in that case, work order will not be issued in favour of the tenderer under any circumstances.
3. **No conditional/incomplete** tender will be accepted under any circumstances.
4. The intending tenderer shall clearly understand that whatever may be the outcome of the present invitation of tender, **no cost of tendering shall be reimbursable** by the Department.
5. **Payment will depend on availability of fund** in appropriate head and no claim whatsoever will be entertained for delay of work after issuance of work order.
6. Work should be completed within stipulated time period. **No extension of time** for the work will be allowed without any cogent reason over which the bidder will have no control and which will retard the progress and the application for extension of time period should be submitted before the expiry date of contract. If extension of time period is taken for granted then the validity of the contract will be extended automatically up to the extended period with all terms and conditions remain unaltered.
7. The prospective bidders should own or arrange through lease hold agreement the required plant and machineries; Conclusive proof of ownership/ arrangement must be submitted.
8. The specification for the works made of execution and measurement will be governed by the specification laid down in the **PWD and WRI&DD schedule** and relevant provision of IS code & as per the direction of tendering authority.
9. **No claim out of typing**, printing, arithmetical and/or clerical mistake anywhere in the tender shall be entertained.
10. **Acceptance of lowest or any other tender is not obligatory** on the part of the tender inviting authority. The authority reserves the right to reject or accept any tender or all tenders without assigning any reason what so ever.
11. **Contractor shall have to comply with the provisions of (a) the contract labour** (Regulation Abolition) Act. 1970 (b) Apprentice Act .1961 and (c) minimum wage Act. 1948 and any notification thereof or any other laws relating thereto and rules made and order issued to this effect from time to time.
12. **All materials to be supplied by the Contractor should be good & approved by the Deputy Director of Agriculture (Soil & Water Management) Suri, Birbhum or his authorized representative before use.** Rejected materials should be cleared from the site within 24 hours of rejection. Payment of materials to be supplied by the contractor will be made as per actual consumption in the work.
13. **Labour Welfare Cess @1(one) %** will be deducted from the final bill of the work. GST & all other statutory levy/ Cess will have to be borne by the Contractor & the rate in the schedule of rates are inclusive of all the taxes &cess stated above.
14. Immediately after taking over the site, the contractor shall inform the tendering authority i.e. Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum about the work programme in writing.
15. The work shall be **carried out strictly according to tendered schedule of work** and specification laid down therein.
