The tenderer/supplier should quote their rate on percentage basis i.e. ABOVE, BELOW or AT PER both in words & figure on the memorandum page of W.B.F.R.-2911/2911 (i)/2911(ii) of the departmental tender schedule of supply including carrying cost to specified spot. The tenderer/supplier should submit quote their rate separately for each Group.

Eligible Contractor/Supplier/Agencies should show their documents in original as enclosed in the application at the time of getting work order.

Acceptance of lowest or any other tender is not obligatory on the part of the undersigned. The undersigned reserves the authority to reject any tender or all tender without assigning any reason what so ever.

The payment will be made as and when fund will be available from the concerned source. No claim/complain, whatsoever for delay in payment, if any, will be entertained. Contractor/Suppliers are requested to quote their rates accordingly.

Terms and conditions

Eligibility criteria for participation in the tender:

The bidder will be established & experienced in undertaking similar nature of work having credential in similar type of work @ 40% of work value of in a single job. Capability statement in separate sheet should submit along with tender. Supply order shall however be placed as per requirement of the authority. It may be a pond to pond supply.

Credential certificate issued by the competent authority of a State/Central Government, State/Central Government undertaking. Statutory/Autonomous bodies constituted under the Central/State statute, on the executed value of completed/running work will be taken as credentials.

Earnest Money:

Earnest money against the work as shown in the above table shall have to be paid online through the portal in favour of the Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum. The earnest money of successful tender will be converted as security deposit. Earnest money of unsuccessful tender will be released after the finalization of the lowest tender.

Mode of Work:

The selected tenderers shall have to complete the work at the spot under supervision of concerned engineer/ officer of this establishment. The date & time of work should be fixed in consultation with the engineer/ officer concerned and to be communicated to the undersigned well in advance.

Payment Terms:

The payment will only be made after satisfactory completion of whole works/ supply . The work/supply must be completed in stipulated time period and No Time Extension of work /supply or any RA bill will be entertained due to delay of work / supply by the successful bidder or tenderer without any valid ground/reason. Extension of time or RA bill will be allowed due to delay of work/supply for natural disaster or any acceptable reason which considering by the respective Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum. Problems like manpower and machinery or Agricultural field/pond/ water bodies should not be allowed. Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum is the sole authority to allow necessary permission for time extension.

Security Deposit:

The successful tenderer shall have to deposit the security money either @ 10% of the tendered value or the balance amount over the Earnest money (2%) already deposited in favour of the Deputy Director of Agriculture (Soil & Water Management), Suri, Birbhum before preparation of final bill. Formal agreement will be done by the successful tenderer with the tender accepting authority within 7(seven) days from the date of issue of acceptance letter. The formal work order/supply order for the supply will be issued after execution of formal agreement by paying agreement fees with an amount of **Rs. 755.00** by the successful tenderer with the tender accepting authority. Total security deposit will be released after 90 days of actual supply.

Agency have to submit Additional Performance Security @10% in addition to scheduled 10% security in form of the “**Bank Guarantee**” in terms of G.O. No. 4608-F(Y), dated, 18/07/2018 before issuance of “Work Order” in his favour. The Additional Performance Security will be returned immediately on successful completion of the contract. If he fails to complete the contract successfully within the scheduled period this additional performance security will be forfeited.

Others:

In case of any unscheduled holidays on the aforesaid dates, the next working date will be treated as schedule/prescribe date for the same purpose.

Final Measurement:

At the time of **final measurement**, the **Agency** will have to be present on site. After final measurement **no claim** of the agency will be entertained.
